#### 2. Team(s)

There is not a maximum number of teams that a WRF Nation can register for the event.

#### Obligations of the Participants:

- Each participant should be present throughout the whole duration of the event.
- Each participant is obliged to take part also in all of the non-sport activities.
- Each team undertakes to compete against all other participating teams.
- Each participant undertakes to compete against all other participants.
- The absence of any member of a participating team from any part of the entire sport program, opening-, prize-giving- and closing ceremonies may result in disqualification of the team.

#### 3. Competition venues

The competition will take place in following venues: Yacht Club "Fregat ", 18 – K, Brovarskoy avenue, Kyiv, Ukraine

#### 4. Rules

The competition will be run according to WRF Rules

#### 5. Doping

Dope testing (for use of banned substances) can take place during the competition according to current WRF Anti-Doping Rules.

If a competitor is following a course of medical treatment which includes the use of prohibited substances according to the WADA prohibited list 2017 https://www.wada-ama.org/sites/default/files/resources/files/2016-09-29\_- \_wada\_prohibited\_list\_2017\_eng\_final.pdf, he or she must obtain from his/her National Anti-Doping Agency (NADO) a TUE (Therapeutic Use Exemption) that complies with the requirements of the International Standard and must inform the organisers immediately upon arrival.

#### 1. Registration

The registration will be open from 1<sup>st</sup> July 2018.

#### 2. Fees
