## 2. Team(s)

There is not a maximum number of teams that a WRF Nation can register for the event. This event is open to no-WRF Teams.

Participants obligations:

Each participant is required to be present throughout the whole duration of the event.

Each participant is obliged to take part also in all of the non-sport activities.

Each team undertakes to compete against all other participating teams.

Each participant undertakes to compete against all other participants.

The absence of any member of a participating team from any part of the entire sport program, opening-, prize-giving- and closing ceremonies may result in the team being excluded from the results.

## 3. Competition venues

The competition will take place in following venues: city of Slunj, Rastoke, Korana River

## 4. Technical Rules

## 5. Doping

Dope testing (for use of banned substances) can take place during the competition according to current WRF Anti-Doping Rules.

If selected for testing a competitor may be accompanied by an adult.

If a competitor is following a course of medical treatment which includes the use of prohibited substances according to the WADA prohibited list 2017

he or she must obtain from his/her National Anti-Doping Agency (NADO) a TUE (Therapeutic Use Exemption) that complies with the requirements of the International Standard and must inform the organizers immediately upon arrival.

# ADMINISTRATION

## 1. Registration

The entry registration form must be duly completed on behalf of the National Organization's President and send it to the Event's Organization (nsminderovac@gmail.com) as soon as possible but at the latest by 10th March 2018.

The registration is open.

## 2. Fees

Participation fee

In accordance with the rules laid down by WRF, the payment to be made to the organizer of the event amounts to 100 euro per team.

The fee covers breakfast and dinner on 17th and 18th March 2018.

Sleeping will be available for free in sports hall, please your own bring sleeping bags.
