4. Doping

Dope testing (for use of banned substances) can take place during the competition according to current WRF Anti-Doping Rules. **(Official Anti-Doping Agency of Turkey going to make two tests during the event)**

If a competitor is following a course of medical treatment which includes the use of prohibited substances according to the WADA prohibited list 2017 https://www.wada-ama.org/sites/default/files/resources/files/2016-09-29_-_wada_prohibited_list_2017_eng_final.pdf, he or she must obtain from his/her National Anti-Doping Agency (NADO) a TUE (Therapeutic Use Exemption) that complies with the requirements of the International Standard and must inform the organisers immediately upon arrival.
